THE PROJECTS BRIGHTON LTD PRIVACY POLICY

1. INTRODUCTION

The Projects Brighton Ltd values your privacy and is dedicated to upholding your trust by safeguarding your personal data. This Privacy Policy ("Policy") outlines how The Projects Brighton Ltd collects, utilises, shares or otherwise handles data that, either alone or combined with other information, allows for your direct or indirect identification ("Personal Data"). Additionally, it explains the rights you have concerning your Personal Data.

This Policy aims to provide you with insight into how The Projects Brighton Ltd processes your Personal Data in the following scenarios:

- When you engage with us on our websites that display or link to this Policy.
- When you use our products and services, including our software and technology platform and applications made available for online or mobile device usage, where we act as a controller of your Personal Data.
- When you function as a service provider, supplier or vendor to The Projects Brighton Ltd.
- When you register for, attend or participate in our events, programs, promotions, or contests.
- When you receive communications from us or interact with us in other ways.
- When you subscribe to receive our newsletters, updates or other communications.
- When you participate in surveys, research or other similar data collection activities facilitated by The Projects Brighton Ltd.
- When you are employed by or affiliated with an organisation or institution that uses our
 products and services and your Personal Data has been shared with us in our capacity
 as a controller (e.g. to authorise your access to your employers, educational institutions
 or another organisations account).
- When you access our locations as a member, service provider or an attendee at an event hosted or co-hosted by The Projects Brighton Ltd.

2. WHO WE ARE

The Projects Brighton Ltd and its affiliated entities take responsibility for managing your Personal Data in accordance with the guidelines outlined in this Policy. Unless specified otherwise, we act as the controller for this Personal Data, meaning we determine the purposes and methods of its collection and use. Depending on your location or where you interact with us, the specific entity within The Projects Brighton Ltd acting as the controller may vary.

When we refer to "The Projects Brighton Ltd," "we," "our," or "us," we are referring to the relevant entity within The Projects Brighton Ltd that holds the role of the controller for your Personal Data.

3. PERSONAL DATA WE COLLECT

As a UK provider of flexible workspace solutions, we gather various types of Personal Data related to your interactions with us and your usage of our products and services. Below, we present the types of personal data we may collect. However, please be aware that not all categories may be relevant to you.

- a) Contact Information: Information like your name, email address, physical address, phone number, date of birth, employer or educational institution name and your role concerning the use of our products and services, along with other contact details where applicable.
- b) Payment Information: Data related to your billing address and payment method, such as bank details, credit card, debit card or other payment card information.
- c) Activity & Usage Data: Information linked to your usage and activities with our products and services, including Membership Activity & Usage Data such as keycard and/or mobile key access records (e.g., date and time of entry or scan at access points), desk and office booking data, printer usage details, credit usage data, desk location data and other data relevant to your usage of our workspaces and membership offerings.
- d) Security Details: Data like images and video footage captured by closed-circuit television (CCTV), access data logs and information collected in connection with security incidents involving you, all pertaining to the safety and security of our locations.
- e) Additional Identification Data: Data including government-issued identity documents, photographs and other information gathered to verify identity, age and prevent fraud.
- f) Account Details: Data associated with your account at The Projects Brighton Ltd such as your chosen username, password, profile picture, and designated "home" location within The Projects Brighton Ltd.
- g) Event Data: Information collected for event and webinar registration and participation, including attendee badge details (e.g., name, title, company name and image), email address and photographs and videos taken during events.
- h) Device, Internet & Network Activity Information: Data which might identify your device, such as device ID or other unique identifiers, or data about your device, such as browser type and geolocation information (if your device settings allow for this), IP address, MAC address and other data related to your device and activity on our websites, mobile applications, emails and online content (as applicable under data protection laws).
- i) Vehicle Information: Data concerning your vehicle, such as vehicle registration and licence plate numbers, to facilitate parking at our locations.
- j) Other Voluntary Personal Data: Data such as the content of your communications with us, including interactions with customer support and our social media channels, participation in surveys, questionnaires, contests, or other promotional offers, data you provide when subscribing to receive news, promotions, or other marketing communications from us or our partners and any other information you willingly share with us.

In specific situations, we may collect the following categories of Personal Data:

- 1) Medical & Health Data: Data collected in connection with incidents or medical emergencies involving you at our locations.
- 2) Other Sensitive Personal Data: Data collected with your consent and used as necessary to perform reasonably expected services or as required by law. We kindly request that you avoid providing any Sensitive Personal Information unless specifically requested.

4. HOW WE COLLECT YOUR PERSONAL DATA

4.1 Directly from You

The majority of your Personal Data is collected directly from you and the specific categories of Personal Data we collect depend on your interactions with us. For instance, when you sign up or activate a membership with The Projects Brighton Ltd, contact us with inquiries about our products or services, access our locations, use our mobile application, participate in surveys, engage with our websites, attend events or webinars, or provide services to us, you may provide us with relevant Personal Data. In certain situations, providing the requested Personal Data may not be mandatory. If you choose not to provide specific Personal Data or decide to opt-out of our processing of your Personal Data (where applicable), you have that right. However, it's important to note that in some cases, the provision of certain Personal Data may be necessary for us to offer our products or services to you or to address your requests effectively.

4.2 From Automated Methods, Devices and Our Network

In addition to direct data collection, we may also gather your Personal Data through automated means and devices without explicitly requesting the information from you. This is standard practice for businesses that operate online and employ technology. The data collected through this method primarily includes information automatically obtained through your interactions with our websites, mobile application, emails and online content. Such data encompasses Device, Internet, and Network Activity Information as well as other details gathered through cookies, web beacons and similar technologies.

4.3 From Other Sources

Helping us correct or supplement our records for marketing campaigns, offers and online advertising efforts, or assisting with sales activities.
Facilitating your use of our products and services as per your directions.

5. PURPOSES FOR PROCESSING YOUR PERSONAL DATA AND LEGAL BASIS

At The Projects Brighton Ltd, we are committed to ensuring that your Personal Data is processed lawfully, in line with data protection laws. Under GDPR regulations, the law mandates that we have a valid legal basis for processing your data. In most cases, we rely on our legitimate interests or those of third parties (except when they are outweighed by your interests or fundamental rights and freedoms), fulfilling contractual obligations with you or complying with legal requirements. Additionally, we may process your Personal Data to protect vital interests, further important public interests, or rely on your consent, whether implied (e.g., when you voluntarily provide information for our use) or expressed as permitted by applicable law.

If we process your Personal Data based on your consent, you have the right to withdraw your consent at any time for activities solely reliant on your consent by contacting hello@projectsclub.co.uk at any time.

6. HOW WE SHARE YOUR PERSONAL DATA

We consider safeguarding your Personal Data as a crucial aspect of our relationship with you; thus, we do not disclose your Personal Data to third parties for sale. However, there are specific situations where we may share, transfer, or disclose your Personal Data to certain third parties ("Third Parties") as described below:

Advertising Partners:

As is common practice among companies operating online, we may share limited Personal Data with non-affiliated business partners, advertising networks, analytics providers and other advertising providers ("Advertising Partners") for the purpose of targeting advertisements on non-The Projects Brighton Ltd websites, applications, and services. Additionally, we may allow certain Advertising Partners to collect limited information from our websites and services using cookies, web beacons and other technologies to tailor online advertisements to your interests and preferences.

Professional Advisors:

We may share your Personal Data with our professional advisors, including lawyers, bankers, auditors and insurers who provide consultancy, legal, banking, auditing, insurance and accounting services to us.

Add-On and Integration Partners:

Through our platform and applications, we may offer integration with non-affiliated third parties ("Add-On Partners") providing additional features, functionality, applications, products or services. If you integrate with or access these Add-Ons, we may share your Personal Data with the associated Add-On Partner to enable your access or use of the Add-Ons.

Organisers, Hosts, and Sponsors:

When you register for, attend, or participate in events we may share your Personal Data with them.

Our Landlords and Building Owners and Managers:

We may share your Personal Data with landlords and building owners and managers as required by our lease and/or management agreements to facilitate access and security at the base building controls where our workspaces are located.

Our Partners (in Connection with your Membership):

Where permitted by law, we may share your Personal Data with select partners that offer products and services related to your membership. For example, we may share your basic Contact Information with specific insurance providers who may contact you to provide products and services to meet your contractual insurance requirements. Where required by applicable law, we will only share your Personal Data with your consent. Our partners are bound by a contractual obligation to process Personal Data only as necessary to offer products and services related to your membership.

Third Parties Involved in Business Transactions:

In the context of business transactions such as mergers, acquisitions, sales or reorganisations, your Personal Data may be shared or transferred (subject to standard confidentiality arrangements)

Other Third-Party Disclosures:

We may share your Personal Data (i) at your direction or with your consent, (ii) if required by law, (iii) to protect our rights, interests, or property, (iv) to prevent or investigate wrongdoing, (v) to enforce our terms and conditions, policies and agreements or (vi) to protect personal safety or against legal liability.

11.7 Precise Location-Based Services

With your explicit consent, we have the option to collect approximate physical location data from your device utilising a range of technologies, including GPS, Bluetooth, cell phone tower locations, Wi-Fi signals and others.
